Online tenders were invited for finalization of Rate, Contract and agency for the purchase of drugs, surgical supplies, lab chemicals , X-Ray items, general items and medical gases etc. under various groups for the institutions under Health Department of East Delhi Municipal Corporation on biennial basis for the years 2017 – 19 vide NIT No.- Addl.DHA(M&TB)/EDMC/2017/115 dated 03.03.2017. In pursuance to decision taken in pre-bid meeting dated 16.03.2017, the schedule was revised as notified vide o.o.no. Addl.DHA(M&TB)/EDMC/2017/89 dated 28.03.2017.

In view of lack of clarification with regards to terms/rates of GST, which is likely to be introduced w.e.f 01.07.2017, a number of representatives of the firms visited Additional Commissioner (H) and expressed their inability in quoting the rates for various items. Mr. Rakesh Mehta, General Secy. MCD Pharma Distributors Association(Regd.) vide letter dated 20.04.2017 represented that "at preset the GST rates and implications are not clear, our companies are not in a position to quote rates against this tender because the effect of GST may increase/decrease the rates" and requested to postpone the said tender till 15.07.2017. The meeting was also attended by Director Hospital Administration, Addl. DHA(M&TB) and the undersigned. It was agreed by all that the schedule of events of the tender in question may be so revised that the closing of purchase & download of tenders starts from second week of July 2017. Accordingly, the schedule has been further revised as under:-
