Some queries were raised in pre-bid meeting replied as under:

S.NO.	QUERRY	REPLY
1.	What will be the Impact of GST for the Rate Contracts to be awarded in respect of providing Open Gym Equipments?	As per section 14.26.2 of Tender Document it has been clearly mentioned that the Rates / price to be quoted by the bidder shall be inclusive of all taxes. However if there is reduction of rates in GST in future, the bidder is compulsorily liable to reduce the rates of Open Gym Equipments to be provided in SDMC in proportion of reduction of GST. Further if there is increase in GST on these Equipments the increase in rates in proportion of increased GST may be considered by SDMC on the request of contractor. Decision of considering or not considering the increased rates by SDMC shall be final.
2.	Item No.13 of Open Gym Equipments in BOQ of Tender No.294944 in respect of Surf Board Item mentioned use of MS Pipe, whereas all other Gym Items are of C-Class GI Pipe, Please clarify.	This Surf Board Item is of C-class GI Pipe. The same may please be noted.
3.	Whether the order(s) for providing Open Gyms Equipments will be issued in bulk or not? If the order(s) are issued for installation of one or two equipments, who will bear the installation charges of Open Gyms Equipments?	The Work Orders will be issued to successful Rate Contract holders as per requirement at different locations. It may be for one or two or more equipments at one site depends on the requirement decided by SDMC. The cost shall be inclusive of all taxes for each equipment / item. Nothing extra shall be paid in this regard.
4.	Whether Technical Bid & Financial Bids may be submitted manually or not?	The financial bids are to be submitted online at e-tender portal of SDMC only. As specified in the tender document the Technical Bids may be submitted online as well as manual till 11.10.2017 upto 03.00 P.M.
