The registered contractors of MCD (SDMC/NDMC/EDMC only are eligible to tender subject to fulfilling the relevant conditions of Technical bid for the amount they are registered in respective category subject to the conditions that they are neither black-listed nor debarred at the time of purchase of tenders Champion.

MANDATORY EXPERIENCE IN SIMILAR WORK Experience of having successfully completed similar works during the last 7 years ending last day of the month previous to the one in which applications are invited. The bidder should have minimum experience of similar nature of works as under:

Three similar completed works costing not less than the amount equal to 40% of estimated cost put to tender. OR Two similar completed works costing not less than the amount equal to 60% of the estimated cost put to tender. OR One similar completed work of aggregate cost not less than the amount equal to 80% of estimated cost put to tender. AND One completed work of any nature costing not less than the amount equal to 40% of the estimated cost put to tender with some Central Government Department / State Government Department/ Central Autonomous Body / Central Public Sector undertaking in India. The completion certificate issued from competent authority be submitted along-with Technical Bids. SIMILAR NATURE OF WORK MEANS: "Improvement / Development work of Park / Garden / Supply of Horticulture Plants"

MANDATORY FINANCIAL TURNOVER

Average annual financial turnover of the participants/Contractors/Bidders during the immediate last three consecutive financial years should be not less than the amount equal to 100% of estimated cost put to tender. Copy of Financial Turnover Certificate, duly certified from a registered CA for the preceding three (3) financial years, should be submitted.

TECHNICAL BID shall comprise- (i) Tender Cost in specified form. (ii) Earnest Money in specified form. (iii) Experience in similar nature of work/s. (iv) Financial Turnover Certificate duly certified by Registered C.A./GST No.

The Technical Bid documents must be uploaded on e-tender portal while submitting the Tender. The Tender Cost & Earnest Money Deposit shall be submitted in the office of Dy. Director(Horticulture)West Zone situated at Zonal office at 60 Block Ashok Nagar , New Delhi-110018. It shall be in the shape of Pay Order/Demand Draft in favour of Commissioner-SDMC, payable at New Delhi and must be submitted upto 10.01.2018 at 15.00 PM positively.

Based on the Technical compliance of each proposal as submitted by the Applicant, Financial bids of only eligible bidders shall be considered for opening.
