Consultant / Consultancy Firm / Artist must have got executed or consulted on a Waste to Art Project similar to this in the last seven years for a Government Institute or Municipality with submission of Completion / performance certificate for the same from the competent authority, for which the work has been done by the intending consultant. Consultant / Consultancy Firm / Artist should have experience with minimum 2 years of working as professional Consultant / Artist. Consultant / Consultancy Firm / Artist / Art firm, dealt with catalogued exhibitions / events of Art work. Consultant / Consultancy Firm / Artist should have experience certificate of working with Waste to Art issued by relevant executing agency.
3. **SELECTION PROCESS** A single stage, two-envelope process (Technical & Financial Bid) will be followed for selection of a suitable contractors for this work. All interested firms that qualify each of the following eligibility criteria may apply. Based on the Technical compliance of each proposal as submitted by the Applicant, SDMC shall shortlist bidders for opening of financial proposal. Financial proposal of the firm/s that qualify the said eligibility criteria shall be opened. The L-1 will be decided on the basis of Techno – Oriented Evaluation Criteria.
4. **PERFORMANCE SECURITY** The L-1 firm decided by the department as per evaluation criteria will be considered for award of work .The successful L-1 Bidder will have to submit the requisite interest free Performance Security equivalent to 5% (Five percent)of the amount of contract in the form of Bank Draft/Pay Order/ Bank Guarantee/ FDR in favour of commissioner, SDMC payable at New Delhi. The said performance security shall be deposited within 10 days of issue of Letter of Intent/Acceptance from SDMC. Failure in timely submission of required Performance Security the EMD deposited by contractor shall be forfeited to the SDMC and further necessary action for debarring / blacklisting of bidder may be initiated by S.D.M.C.
5. **BID SUBMISSION:** Online Download, Bid Preparation and Hash Submission, Re-encryption of Online Bid is as per time-table given above. The MCD registered contractors may submit their bids online and eligible contractors / consultant(s) other than MCD shall submit their bids manually in sealed cover. The proposal shall contain the Technical & Financial Bids in separate Envelope. Envelope-I duly sealed shall contain Technical bid documents. The envelope shall be marked "Technical Bid only" The EMD is to be kept in Technical Bid envelope. The Tenders not accompanied by Earnest Money in prescribed form shall be summarily rejected. Envelope-II shall contain Financial Bid only in another Sealed Envelope and shall be marked as "FINANCIAL BID ONLY".
6. The competent authority on behalf of the SDMC does not bind itself to accept the lowest or any other tender and reserves to itself the authority to reject any or all the tenders received without the assignment of any reason. All tenders in which any of the prescribed conditions is not fulfilled or any condition or any condition including that of conditional rebate is put forth by the bidder shall be summarily rejected.
7. S.D.M.C. may disqualify any Applicant/Bidder without notice who submits an incomplete/non-eligible bid. SDMC reserves the right, without any obligation or liability, to accept or reject any or all the proposals at any stage of the process, to cancel or modify the process or any part thereof or to vary any of the terms and conditions at any time, without assigning any reason whatsoever.
8. The date & time of different activities of tendering process may be checked on the SDMC website from time to time. In case of holiday / holiday declared on the scheduled dates of closing/opening the same will be done on the next working day.
