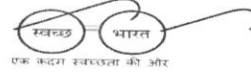

Some queries were raised in pre-bid meeting were explained / replied to the satisfaction of probable bidders and some of them are given as under:

S.NO.	QUERY	REPLY
1.	Whether Technical Bid & Financial Bids can be submitted manually or not?	The financial bids are to be submitted online only at e-tender portal of SDMC only. The Technical Bids submission has been allowed online as well as manual as per tender document.
2.	Whether the EMD in the form of FDR & Bank Guarantee will be accepted?	The bid security (EMD) shall be paid by way of Demand Draft/Bankers Cheque/ Pay order/Bank Guarantee only
3.	What will be the Experience criteria and nature of similar work for qualifying in tender.	Bidder should have experience of successfully executing similar nature of works costing above Rs.80.00 lacs(minimum three works) OR work above Rs.120.00 Lacs (minimum two works) OR work above Rs.160.00 lacs (minimum one work) AND One completed work of any nature costing not less than the amount equal to Rs.80.00 Lacs with some Central Government Department/ State Government Department/ Central Autonomous Body/Central Public Sector undertaking/State Public Sector Undertaking/ City Development Authority/ Municipal Corporation of City formed under any act by Central/State Government and published in Central/State Gazette. Completed Similar nature of work means "the work of supply/installation/providing/fixing of precast RCC benches / work of Casting in Cement Concrete"
4.	Who will born the Testing charges of samples to be submitted by the bidder.	The testing charges of samples submitted with Technical bids will be borne by the SDMC, as has been mentioned in the tender document at Chapter-III point 6(b).
5.	Where the samples of RCC benches are to be submitted as required in Technical Bids.	The necessary samples are to be submitted with Section Officer (Hort.)HQ on any working day between 09.00 A.M. to 05.00 P.M. and on 20.08.2018 upto 03.00 P.M. at "Central Store of Horticulture Department, situated at Jangpura under Defence Colony Flyover, New Delhi-110014".
6.	Whether the cost of 3 <sup>rd</sup> party inspection will be borne by the SDMC or not. If the charges are to be paid by contractor, then these will be reimbursed to the contractor or not.	As has already mentioned in tender document Chapter-III point 15.8 Third Party Quality Control check in respect of items required will be got done, by getting the samples of RCC benches tested from Sri Ram Laboratory in Delhi or Government designated / authorised Lab/s, as decided by the SDMC from time to time. All testing charges on this account shall be borne by the contractor. Nothing will be reimbursed to the contractor from SDMC in this regard.
