The following conditions shall also apply: -


1. The offer should be valid for minimum 30 days from the opening of price bid.
2. The supply is to be executed within 30 days.
3. The rates are to be quoted mentioning all taxes/ GST clearly. No post modifications on tax/ Govt. Levy will be allowed/ accepted and manufacture's / authorized dealers will be wholly responsible for the total amount of GST to be deposited.
4. The Contract Agreement is to be executed with Department and necessary terms & conditions of the Department are also to be signed by the lowest offer within 3 days on a non-judicial stamp paper of Rs. 50/-.
5. The supply of item/material will be warranted as per manufactures and the bidder has to submit supporting documents.


6. Earnest Money and performance guarantee should be taken in the form of Bank Guarantee @5% that will be refund after delivery.
7. 100% Payment will be made against delivery by way of cheque.
8. Action will be taken against the firm if the supply is not completed within the stipulated period.
9. The tender fee will not be reimbursed for any expensed incurred in preparations or submission of tender or for any other reason for the period it remains with the Department.
10. The Department (SDMC) reserves the right of reject any of or all the tenders without assigning any reason.


