Similar works shall means for item no. 1 to 6: Providing manpower services on hiring basis and for item no. 7 to 11 as Supply of E&M equipments. The value of executed works shall be brought to current costing level by enhancing the actual value of work at simple rate of 7% per annum; calculated from the date of completion to last date of receipt of applications for tenders.
- 3. Documents to be submitted in the technical bid are as under:-

a. Documents in respect of (i) GST (ii) Income Tax

- b. The certificate of satisfactory performance in respect of the executed works duly signed by the concerned Ex. Engineer or
- c. The certificate that the firms/ agencies has not been blacklisted/ debarred from any Govt. / Semi Govt. / PSU organization as on date of submission of bids.

d. Certificate from the bidder that the offer is as per NIT specifications/ terms & conditions and there is no deviation.

- e. For deployment of labour cases: Copy of EPF and ESI registration with labour department if applicable on the firm. In case of below 10 (ten) workers, the group insurance is must.
- The separate demand drafts for tender cost and earnest money payable to Commissioner, SDMC shall be submitted by the bidder in the office of the undersigned while purchasing and submission of tender documents.
- The financial bids of only those tenders will be opened whose technical bid are approved by the competent authority in due
- The lowest tenderer will enter into the Contract-Agreement through its proprietor or Authorized Nominee with deptt. on 6. prescribed performa on a Non Judicial stamp paper of Rs. 100/-.
- The department at its sole discretion and without assigning any reason thereof, reserve the rights to accept / reject, any / all, bids. The department does not bind itself to accept the lowest bid.
