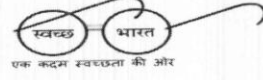

S.H.: MINUTES AND REPLY OF QUERIES OF PRE-BID MEETING HELD ON 26.07.2019

The Online tenders for above subjected work have been invited vide Tender No. 315176 issued vide No. DDH/(HQ)/SDMC/2019-20/459/nit No.1 dated 16.07.2019. The pre-bid meeting was held on 26.07.2019 at 1400 hours. The pre-bid meeting was attended by the representatives of following firms:

Some queries were raised in pre-bid meeting were explained / replied to the satisfaction of probable bidders and some of them are given as under:

S.NO.	QUERRY	REPLY
1.	Whether the EMD in the form of Bank Guarantee will be accepted?	The bid security (EMD) shall be paid by way of Demand Draft/Bankers Cheque/ Pay order/Bank Guarantee only, payable at New Delhi in favour of Commissioner, SDMC.
2.	After award of Rate Contracts the period of Work Orders for execution of works be allowed two to three months instead of 30 days.	Depends on the urgency of work, the period of execution of works may be given from 30 days to 90 days.
3.	G.I. Chain coating be of Rubber Coating or PVC coating in swings etc.	It should be PVC coating.
4.	In the specification the material for seats in Children Play Equipments has been mentioned of FRP material, whether the LLDPE material is allowed. Clamps of rope may be allowed of Nylon in place of LLDPE.	The specifications mentioned in the tender documents shall be complied by all the bidders / successful Rate Contract holders. However, if there is better quality it will be allowed with prior approval from SDMC during execution of works of Rate Contract.
5.	Whether Technical Bid & Financial Bids can be submitted manually or not?	The financial bids are to be submitted online only at e-tender portal of SDMC only. The Technical Bids submission has been allowed online as well as manual as per tender document.
