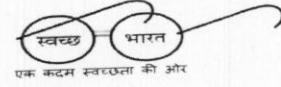

1.	What is the Location for waste / scrap materials stacked by SDMC?	Necessary detail has already been provided in the tender document at Section 2.3
2.	Minimum Average annual turnover required for eligibility?	The Bidder should have financial turnover Average minimum Rs.703.00 lacs of last three years. Copy of Financial Turnover Certificate, duly certified from a registered CA for the preceding three financial years, should be submitted.
3.	In financial bid whether the GST will be paid extra or not?	The item-wise rate to be submitted online shall be inclusive of all applicable taxes including GST.
4.	What will be the payment schedule of bills for this work?	The payments will be released by the SDMC (subject to deduction of statutory taxes and levies, if any) as per execution of work and as per availability of funds. The running bills may be paid to the contractor for different stages / work, which shall be on the discretion of SDMC. Necessary detail has already been provided in the tender document at Section 4.21.
