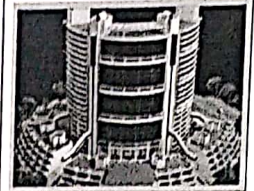

It is submitted that a pre-bid meeting with reference to tender No.D-001/NIT/SDMC/MDM/Edu./HQ/2020 Dated: 03.01.2020 for The e-tender for Expression of interest (EOI) from interested voluntary organization/Non Government organization for providing fresh cooked food under Mid Day Meal Scheme of the schools of South Delhi Municipal Corporation in Najafgarh Zone. Seven (07) firms/NGO'S have raised some queries and sought clarification thereof. The point wise clarification sought by each firm is as under:-

1.	If a Voluntary organization undertaking to spend more than the notified amount Rs.4.48 per meal for enhancing the quality of MDM, due preference would be given to such organization: if NGO is working on No profit basis how it will be possible?	No Change, As per NIT
2.	The rental value of the kitchen area approximately at the rate of Rs.(8600*500)= Rs 4,30,000 per month or more to be finalized for award of tender: As rental of kitchens is so expensive that if will have an effect on the Mid Day Meal and as similar space can be easily availed within Rs50,000 to 1,00,000 from outside.	No Change, As per NIT.
3.	Rent applicable on work order or starting day of supplying MDM	Rent applicable on starting day of supplying MDM.
4.	The successful bidder will have to deposit quarterly rent in advance The SDMC will Endeavour to make payment within 45 working days after submission of Subsidy Bills.	No Change, As per NIT
5.	If voluntary organization does not Supply cooked food on particulars day (s) or fails to replace the defective/unsatisfactory supply of cooked food in time a penalty amounting to double of conversion charges per child present in that particular school on particular day shall be deducted from bills.	No Change, As per NIT
6.	A sum of Rs20,00,000 (Twenty Lakhs only) shall be deposited in the form of Bank Guarantee/Fixed Deposit in the name of Commissioner, SDMC as earnest money/ performance security at the time of Submission of Application (EOI): Since this amount is very high and it will impact on Financial position of NGO	No Change, As per NIT
7.	If wheat and rice is received from FCI in advance by the Voluntary organization then they will have to submit the bank Guarantee of the amount equivalent to tentative value of food grain given as advance. The voluntary organization may given undertaking to return of unutilized/Balance as per stock record of wheat and rice is received from FCI.	No Change, As per NIT
8.	Health fitness certificate any provide Agency	Health certificate of all employees to be issued by any Regd. medical practitioner.
9.	Fitout time limit not mentioned	45 days.
