**ENGAGEMENT OF A CONTRACTOR BY SDMC (Lead Corporation on behalf of all the three Municipal Corporations of Delhi) FOR TOLL & ENVIRONMENT COMPENSATION CHARGE (ECC) COLLECTION AT BORDER POINTS FROM SPECIFIED COMMERCIAL VEHICLES ENTERING DELHI**

The South Delhi Municipal Corporation (SDMC) invites **online** technical and financial proposals through [www.tenderwizard.com/SOUTHDMCETENDER](http://www.tenderwizard.com/SOUTHDMCETENDER) from interested developers/ toll plaza operators to collect toll tax from specified commercial vehicles, upgrade/modify, operate, and maintain 124 toll plazas/posts/barriers locations bordering Delhi. In addition to toll collection, the contractor shall also separately collect ECC as per actual basis and deposit the same on weekly basis. Collection of Toll & ECC shall be through newly installed RFID System at 13 entry points and manually or likely to be installed RFID system at remaining entry points of Delhi

The work shall be granted for a period of 3 years extendable for further six month, if decided by Commissioner, SDMC with provision of increase of 5% (five percent) in the existing awarded amount / committed amount after two years.
