Following Formula shall be used for the revision of Tipping fee based on WPI: Tipping for Financial Year. $= \{ \text{WPI}(\text{Ft}) * \} \frac{\text{QTo}}{\text{WPI}(\text{Fo})}$ Where, WPI (Ft)- Wholesale Price Index for the Financial Year in Question as declared on 14th April of that year WPI (Fo)- WPI as notified on 14 April 2014) QTo- Quoted Tipping Fee for Financial Year 2014-15 For Example:- Let us say- WPI (Ft) = 176.94 WPI (Fo) = 167.62 QTo = Rs.1500 Tipping for the Financial Year in Question = $176.94 * 1500 / 167.62 = 1583.40$
