The tender cost (Non-refundable) will be paid by the contractor at the time of application for purchase of tender. The Earnest Money of each work shall be submitted in the tender box alongwith Tender document in the office of Deputy Director Horticulture(HQ)SDMC at Civic Centre , New Delhi-110002 on 09/01/2015 from 09.00 AM to 1.00 PM. The tenders will be opened on the same day at 1.30 PM in the presence of A.A.O.(HORT.) and the contractors present, if any. The earnest Money and Tender cost will be paid by the contractor in the form of Demand Draft/ Pay Orders in favour of **Commissioner, SDMC** payable at New Delhi. The desirous contractors can purchase the tender document on submission of application with Pay order of Tender Cost. They will have to submit the copy of Registration Certificate in SDMC, ITCC, VAT Return/Registration documents etc.with the application for the purchase of tender. In case of holiday /holiday declared on the above scheduled dates the same will be done on the next working day.
