1.	Please note that Section II of the document as mentioned in Clause 1.3 of the EOI is not available. Kindly provide.	The same shall be provided to the eligible bidders, submitting the EOI.
2	Clause 1.7, Serial No. 2 says that "The Lead-Partner should not have incurred financial losses in more than two years during the immediate last five consecutive financial years". We request to remove the criteria of 'profit making company' while the 'Sales Turnover' and 'Net Worth' criteria can be suitable increased, as the infrastructure based companies make losses in the initial years due to the nature of business of financial capability of Associate companies can be allowed to meet the specified criteria.	The lead partner should have gained financial profit in any of the year during the immediate last five consecutive financial years.

3	Preliminary: In Para 1.3. Introduction to the Project and Para 1.4. Broad Scope of Work: It is mentioned quote "please refer to Terms of Reference Section-II specified in terms of reference of project and scope of work: unquote, but the same is missing in the document. Experience to be counted for ongoing project (s) also, but must have completed at least one project of 100 apartments." ii)SI.No. 7 against 'Manpower Strength' in the 3 rd column "OR" may be inserted between the two given conditions mentioned therein	i) No change ii) No change
