1.	It should must be made compulsory that basic machine used in manufacturing process should be owned by the company like. Powder coating plant, Rotational molding plant, pipe bending machine, welding and fabrication facilities, FRP mold making and manufacturing in house facility, Quality control lab with testing equipment's.	Necessary amendments have been made in the evaluation Criteria. May please see the amended evaluation criteria as per Addendum of the RFP.
2.	As per Open Air Gym Concept it new there are no national or international standard for its design, different companies are following different design concepts only considering safety measures. EN 16630 very new and is for European country. As weather condition and usability of the equipment's are totally different. We should not use those standards	EN16630 certification is concerned with quality, design and safety standards of the equipments and can not be dispensed with.
3.	There are some confusion in technical specification, its written in that equipment's should be muse made of B class pipe whereas, in details all the components asked are in C class pipe. So it should must be either B class for complete equipment or c class for complete equipment	The G.I. pipe to be used in the Open Gym Equipments shall be of "C" Grade quality. Accordingly, the corrected Financial bid-cum-quotation of rates form with specification may be seen as per Addendum of the RFP.

1.	To confirm whether the manufacturing firm has adequate plant and machinery for production of open gym to meet out supply of such large quantities. The participant should have in house provision of following plants and machinery: Automatic pipe bending machine, Fixture for at least five items to be quoted in the tender, Lathe machine, powder coating plant along-with gun, power saw, shearing machine.	Necessary amendments have been made in the evaluation Criteria. May please see the amended evaluation criteria as per Addendum of the RFP
2.	Please confirm whether the site inspection will be done to confirm manufacturing facility.	If the department feels it necessary can visit the Manufacturer unit to its satisfaction. The inspection will be done after opening of Technical bids of the bidder and/or before award of work and/or after award of work
3.	Make it mandatory for the participating firms to show one work experience of at least 40% of the tender amount of open gym specifically as awarding work of such a magnitude without any past experience in the same product will not be prudent.	Necessary experience has been sought in the R.F.P.
