The eligible contractors shall have to Pay the Tender Cost and Earnest Money mentioned against the work at the time of download of tender documents and the same has to be deposited at the time of Re-encryption of online bid and same will be received in the office of Ex. Engg. (Electrical)-IV/SZ, Under Seva Nagar Flyover, Bhisham Pitamah Marg, New Delhi-110003
6. VAT (value-Added Tax) @ 4/5 % VAT will be deducted at the time of making payment to the contractor/ at the time of crediting such an amount to the account of the contractor, whichever is earlier.

If the rate quoted by the lowest tenderer are found abnormally low the payment to the contractor for the work shall only be made after inspection by the Comptroller/Controllor cell at different stages and these finding shall be final and binding on the Contractor. All the testing charges from the independent laboratory shall be borne by the contractor. In case, the lowest contractor fails to commence/complete the work within the stipulated part of the contractor shall be liable for disciplinary action as per the provision of the enlistment rule / instruction issued from time to time.


