The drafts of EMD and tender cost will be received and opened in the O/o SEE(E) as per above schedule. The tenders are also available on mcdonline.com.

For open category bidder:-

Prequalification Criteria

- The intending bidder must get themselves registered with MCD e-tendering from M/s Tech-Mahendra, 24th Floor, Dr. SPM Civic Center, New Delhi-110002 for online sale / purchase of tender.
- Should have satisfactorily completed the works as mentioned below during the last seven years ending previous day of last date of submission of tenders. These similar works each costing not less than 40% of the tender amount, or two similar works each costing not less than 60% of the tender amount, or one similar work costing not less than Rs. 80% of the tender amount

and

- Department/Central Autonomous Body/State Autonomous Body/ Central Public Sector Undertaking/ State Public Sector Undertaking/City Development Authority/ Municipal Corporation of City formed under any Act by Central/ State Government and published in Central/State Gazette.

Similar work shall mean works of "Electrical Installations."

- The value of executed works shall be brought to current costing level by enhancing the actual value of work at simple rate of 7% per annum, calculated from the date of completion to last date of receipt of applications for tenders.
- Should have had average annual financial turnover of 100% of the tender amount during the immediate last 3 consecutive financial year.
- Should not have incurred any loss in more than two years during the last five years during the previous financial year.
- Should have a solvency of 40% of the tender amount.

For Electrical contractor registered in MCD

The registered Electrical contractor under class-II & above of MCD only will submit the valid MCD electrical registration license/certificate (scanned copy) in support of the same online, i.e. through e-tendering system

Term & Condition:-

- All terms Conditions given in the printed NIT from A-32, Chapter 9 of the Municipal Accounts Code Part I will hold good.
- The contractor will have to give a declaration about the name of their relatives employed in MCD along with each tender.
- Bidding Documents can be downloaded from the website-<http://mcdtenders.com>.

- Both Tender cost and Earnest money can be deposited in the form of Bank Draft or a scheduled Bank in favour of Commissioner, South Delhi Municipal Corporation.
- The desirous contractors shall have to Pay the Tender Cost and Earnest Money mentioned against the work at the time of download of tender documents and the same has to be deposited at the time of Re-encryption of online bid and same will be received in the office of SEE(E)/SDMC, 19th Floor, Civic Centre, JLN Marg, New Delhi.

- VAT (Value added tax) as applicable will be deducted.

- If the rate quoted by the lowest tenderer are found abnormally low i.e. more than 25% below the justified rates. The payment to the contractor for the work shall only be made after inspection by the Quality Control cell at different stages and these finding shall be final and binding on the Contractor. All the testing charges from the independent laboratory shall be borne by the contractor. In case, the lowest contractor fails to commence/complete the work within the stipulated period, the contractor shall be liable for disciplinary action as per the provision of the enactment rule / instruction issued from time to time.

- Labour cess @ 1% will be deducted from all Bills / Payments of contractor in compliance of the Building and Construction Worker Welfare Cess Act. & Rules 1996.
- All other standard terms & conditions of same will be applicable & binding to all contractors (available online with tendering documents.)

- Circular Vide No 04/EE(P)-HSDMC/2014-15 DATED 08.04.2015 & Circular Vide No SE(Q)/SDMC/EE(Q)-HSDMC/2015-16/D-1020 DATED 29.07.2015 regarding third party quality assurance will be applicable and charges for the 3rd Party quality assurance is to be borne by the contractor.

- In case of item having abnormally high rates, the executed quantity shall be kept within the BOQ quantity and in case of abnormally low rates, it will be ensure that the executed quantity will be at least equal to the BOQ quantity. However in the instant of quantity executed for the abnormally high rate item is higher than the BOQ quantity, the payment for the quantity executed above the BOQ quantity will be made on justified rates. Similarly in the instant of quantity executed for the abnormally low rate item is lower than the BOQ quantity, the recovery for the quantity executed below the BOQ quantity will be made on justified rates.

- Security deposit will be 10 % for registered electrical contractor of MCD
- Security deposit will be 5 % and Performance Guarantee will be 5% for other bidders
- All tenders issued by MCD time to time is applicable.
