CORRIGENDUM

Subject: Tender Notice No AC/Tender /Advtt./SDMC/2016/NIT/D-402 dated 17.06.2016.

Following partial changes / modifications have been made to subject cited Tender Notice:

1. *Date for receipt of tenders has been extended upto 29/7/2016 till 3.00PM*
2. Annexure-1', Table -A in the aforesaid tender has been replaced with new Annexure-1 Table-A, as uploaded with this corrigendum. (Regarding Najafgarh Zone only : - 59 unipole sites have been changed to 51 unipole sites and seven clusters have been changed to six clusters other changes regarding locations/site etc have been incorporated)
3. *Under the heading eligibility criteria and Essential Pre-Requisites :*

The following changes have been made:

Net worth for the financial year 2014-15 i.e as on 31/3/2015 shall hold good instead of Net worth for the financial year 2015-16 i.e as on 31/3/2016. Accordingly, annual turnover/net profit shall also be considered for the FY 2012-13, 2013-14 and 2014-2015 instead of FY 2013-14, 2014-15 and 2015-2016.

Requisite Profit and loss statement and Audited Balance Sheets of the bidder, for the preceding three financial shall be considered for the FY 2012-2013 onwards in lieu of FY 2013-2014, invariably all duly audited/certified as required in tender.

Accordingly illustration as note:-1 shall be as follows:

If a bidder is applying for all the clusters i.e 06 clusters of Najafgarh Zone, 02 clusters of West Zone and 01 Cluster of South Zone and 02 cluster of Central Zone then minimum annual average turnover of the bidder during the last three financial years must be Rs 17,84,18,000/- or more instead of 22,42,19,500/-or more and the minimum net worth as on 31/3/2015 must be Rs 4,46,12,500/- or more instead of Rs 5,60,70,000/- or more and similar criteria i.e in case , bidder is applying for more than one cluster then minimum annual average financial turnover shall be summation of minimum annual average financial turnover for applied clusters and similarly for net worth.

Rest of the terms/conditions/criteria etc. of NIT remains unchanged.
