1.	Experience in similar work.	Completed similar work/s means the work of supply/ installation of Outdoor Gym/Open Gym/Children Play Equipment / Apparatus. Bidder should have relevant experience as per Tender Document. However, as per clarification sought in pre-bid meeting it is clarified that if the bidder submits the experience certificate of completed work/s of desired amount from Central Government Department/ State Government Department/ Central Autonomous Body/ Central Public Sector undertaking/ State Public Sector Undertaking/ City Development Authority/ Municipal Corporation of City formed under any act by Central/State Government, then it will be sufficient and no separate work completed experience is required of Government work of minimum amount of Rs.200.00 lacs as per tender document.
2.	Certificate of EN 16630 as per clause 8.2.3.2	As per Evaluation criteria, in section 8.2.3.2 if the bidder submits EN 16630 certification for any Equipment of Open Gym, mentioned in the Tender Document, in the name of Manufacturer

Whether the experience certificate of completion in earlier joint venture firm of three will be considered or not?	The completion experience certificate will be considered of the firms in accordance to their share-holding in the earlier joint venture firm. Necessary documentary evidence/proof in this regard shall be submitted by the bidder.
5.	Whether Technical Bid & Financial Bids are to be submitted online.	The financial bids are to be submitted online only. The Technical Bids may be submitted online as well as manual. The manual Technical bids shall be submitted till 07.09.2016 upto 03.00 P.M.
6.	Submission of EMD by Joint Venture Firms.	E.M.D. shall be submitted only in the name of the Joint Venture (JV) and not in the name of the constituent member as has been specified in clause 3.6.17.
