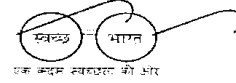

Joint Ventures Firms of Indian Manufacturer/ their dealer/distributors are also allowed to participate in the Tender. The tenders will be received as per time table and Technical Bids will be opened on 09.11.2016 at 15:01 PM at website <http://engineering.mcdetenders.com/common> <http://SDMCetenders.com>. The contractors shall submit an undertaking that the firm has not been blacklisted/Debarred /Banned anywhere in India by any Government department/Government Undertaking.

A single stage, two-bid system (Technical & Financial Bid) will be followed for selection of a suitable contractor for this work. All interested firms that qualify each of the following eligibility criteria may apply. Based on the Technical compliance of each proposal as submitted by the Applicant, SDMC shall shortlist bidders for opening of financial proposal. Financial proposal of the firm/s that qualify the said eligibility criteria shall be opened. The firm having the lowest financial bid will be considered for award of work.

**BID SUBMISSION:** Eligible Bidders may submit their bids. **TECHNICAL BID** The Technical Bids may be submitted online as well as Manual. However the copy of documents submitted online for technical bids must also be submitted in the office of Dy. Director upto 09.11.2016 upto 1500 hours. Date for submission of manual Technical Bids 09.11.2016 till 1500 hrs. The Technical Bids shall be opened on the same day at 1501 Hrs.

**FINANCIAL BID** The Financial bids be submitted online at SDMC e-tenders portal website <http://engineering.mcdetenders.com/common> upto 07.11.2016 till 1500 hours. Re-encryption of Online Bid will be done by the bidders w.e.f. 07.11.2016 from 05:01 P.M. to 09.11.2016 upto 03:00 P.M. The financial bid of only technically qualifying firms shall be opened thereof and date of opening of financial bids shall be informed to the technically qualified bidders.

**MANDATORY FINANCIAL TURNOVER** Average annual financial turnover on works should be at least Rs.250.00 Lacs during the immediate last three consecutive financial years.

**MANDATORY SOLVENCY CERTIFICATE:** Bidders will submit original Solvency certificate for a minimum amount equal to Rs.100.00 Lacs or more from a Nationalised/Scheduled bank in India. Solvency Certificate in original must be submitted along-with Technical Bid Documents. (photocopy of the solvency certificate shall not be entertained).

**MANDATORY EXPERIENCE IN SIMILAR WORK:** Bidder should have experience of successfully executing similar nature of work/s costing above Rs.100.00 lacs (minimum three works) OR Rs.150.00 Lacs (minimum two works) OR Rs.200.00 lacs (minimum one work) AND One completed work of any nature costing not less than the amount equal to Rs.100.00 Lacs with some Central Government Department/ State Government Department/ Central Autonomous Body/Central Public Sector undertaking/State Public Sector Undertaking/ City Development Authority/ Municipal Corporation of City formed under any act by Central/State Government and published in Central/State Gazette. Completed similar work/s means the work of supply/installation of Children Play Equipment/ Children Play Apparatus.

#### PERFORMANCE SECURITY

The successful L-1 contractor / bidder shall submit Performance security equal to an amount of 10% of the amount of contract in the form of Bank Draft / Pay Order / Bank Guarantee / FDR in favour of Commissioner, SDMC payable at New Delhi. The said performance security shall be deposited within 15 days of issue of Letter of Intent /Acceptance from SDMC.

The quoted rates will hold good for 06 months. In case of holiday / holiday declared on the scheduled dates of closing/opening the same will be done on the next working day.

The time allowed for carrying out the work will be Six Months from the 10th day after the date of written orders to commence the work or from the first date of handing over of the site, whichever is later, in accordance with the phasing, if any, indicated in the tender documents.

Tender cost of Rs.1000/- ( Non refundable) shall be made by way of Demand Draft/Bankers Cheque/ Pay order ONLY.

The bid security (EMD) is Rs.5,00,000/- (Rupees Five lac only) shall be paid by way of Demand Draft/Bankers Cheque/ Pay order/Bank Guarantee only.

The payments of Tender Cost and Earnest Money should be drawn in favour of Commissioner, SDMC payable at New Delhi and may be submitted alongwith Technical Bids and will be received in the Office of Dy. 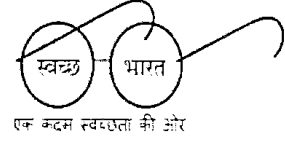
